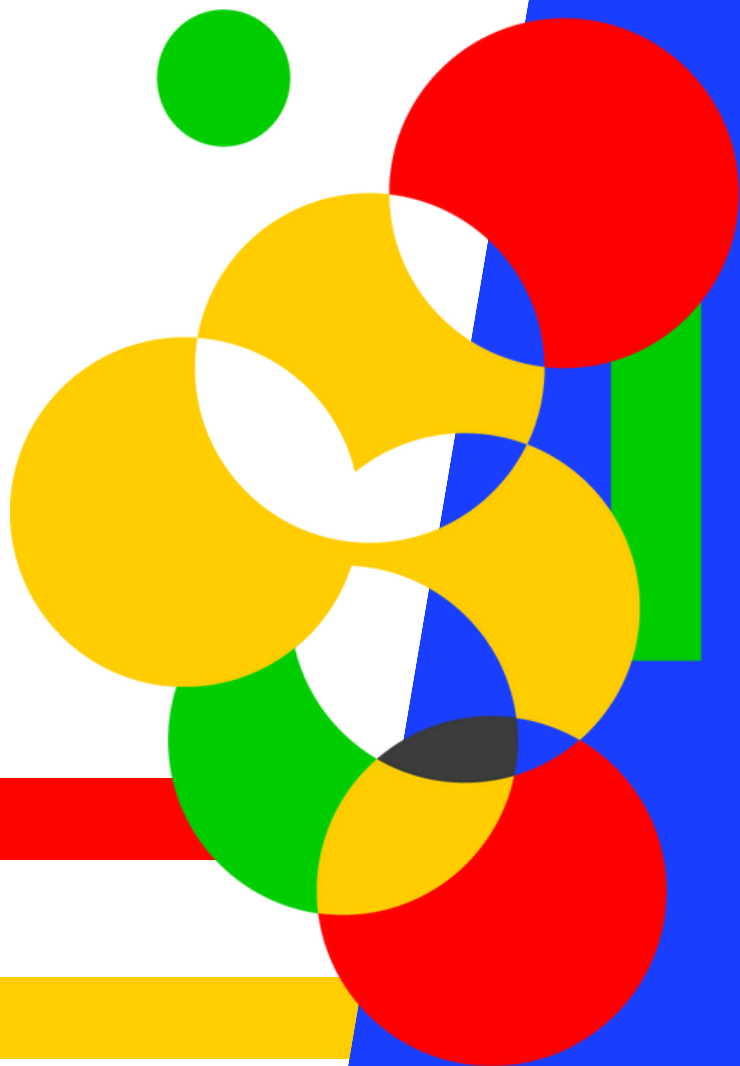

3	Create a State Reference Center, after conducting a public consultation with the target audience, participating in the construction process with the collegiate bodies that deal with the subject at the state level, to assist Migrants, Stateless, Refugees and/or Returnees, with trained and multilingual employees, preferably hired among the target populations, offering legal, psychological, social assistance, documentary regularization, temporary shelter in situations of risk and emergency and others necessary for insertion in the labor market.	42
6	Promote the insertion of migrants in the labor market, through: creation of a Portuguese language teaching platform, focused on the labor market; access to labor intermediation institutions; access to information to avoid their exploitation in the labor market, provision of vocational courses through the S System and the State and/or Metropolitan Solidarity Economy Forum, with an intercultural focus, in several languages and with free teaching materials, and creation of incentives for entrepreneurship, such as offering credit and a place to attend.	28

1	Flexibilize resolution CEE MG 441/2001 and the rules on the revalidation of school diplomas or certificates issued abroad, at the level of basic, middle and vocational education obtained by refugees, migrants, stateless persons and returnees, adopting the following measures: 1) articulate exemptions from fees for vulnerable populations and exemption from documents in the revalidation process issued by countries that are affected by armed conflicts, humanitarian, political and economic crises; 2) create informative booklets on the process of revalidation of diplomas.	75

2	Develop communicative products, in several languages, to inform migrant, refugee, indigenous, stateless and returned communities about their rights, access to public and private services, social programs, among others, including disseminating educational material on good health practices, emergency and urgency care, guarantee of access to information for women (cis and trans) and people with the ability to gestate (trans men and non-binary people), sexual and reproductive health care networks.	10

1	Flexibilize and debureaucratize the rules governing the equivalence and revalidation of high school and vocational education certificates obtained abroad, removing the requirement of apostille for the validation of these documents issued outside Brazil, and exempt the target population from the rates required for the revalidation of undergraduate and postgraduate diplomas stricto sensu, mainly to include migrants from countries affected by internal conflicts, humanitarian, economic and political crises, facilitating their access to more qualified employment opportunities.	17
2	Create and implement a program that promotes business plans for entrepreneurship, with technical assistance to identify investment possibilities in the places of residence of migrants, refugees, stateless persons and returnees, giving assertiveness to business, and reducing the risks of loss of financial resources.	15
6	Promote and facilitate the access of migrant, refugee and stateless women artists or whose trade or profession is linked to the field of art and culture, programs to promote culture and financial incentives for projects and cultural and artistic actions, as a form of socioeconomic insertion. Value handicrafts, creating centers for the construction of these articles and their sale.	12
7	Create the "Community Mothers" Program as a device of the support network and care space for the children of migrant, refugee and stateless women, which enables their insertion in the labor market, being offered by migrant, refugee and stateless women through public financing and monitoring of related public services. Promote the inclusion of migrant women by prioritizing their children in public daycare centers to facilitate their inclusion in the labor market.	10

1	Encourage the protagonism and preservation of the cultural memory of migrant, refugee, stateless and returned people, through the recognition of masters of migrant and refugee popular culture by government bodies, fostering the strengthening, visibility and recognition of their contribution to society, through the creation of memory collections, awards and titles, among others.	14
2	Ensure due observation of linguistic, cultural, social, economic, ethnic-racial and gender issues in the structuring of the provision of public services, ensuring proper access to information about services in different languages and encouraging the adoption of actions that consider the specificities of migrant, refugee and stateless populations in existing policies.	18
4	Formulate a national law that regulates the obligation to hire interpreters for different languages (including Creole, Warao, Arabic, Farsi, among others) to work in public facilities (such as CRAs, CREAS, UPA, UBS, etc.), prioritizing especially the territories that have the most significant numbers of migrants, refugees and stateless people registered in the territories covered by these facilities, as well as offering Portuguese and Libras courses as host languages for people using these facilities.	20
5	Promote and implement affirmative actions for the insertion of migrant, refugee, stateless and returned artists in federal cultural public policies through: 1) translation of notices into different languages and dissemination in official media; 2) inclusion of these populations in the cultural initiatives of federated entities; 3) establishment of quotas, specific scores and adaptation of the necessary documentary requirements, taking into account the specificities of these populations; 4) expansion of cultural public financing.	14
9	Building, from an intersectional approach in all its racial, class, nationality, gender and sexual orientation diversity, a public policy that guarantees quality training for migrants, including their families - especially mothers - as educational agents to contribute with knowledge from other latitudes, thus guaranteeing the right to participate in the cultural life of the community, understanding the contribution of cultural difference and confluence as enriching the social fabric.	16

1	Promote a constitutional amendment to guarantee the right to vote for migrants, refugees and stateless people for the elective positions of president, governor, mayor, deputies, senators, councilors and guardians of the country, emphasizing the full exercise of the political participation of women, especially black and indigenous women, as well as their political representation, via Proposed Amendment to the Constitution (PEC) 25/2012, respecting the right to use the social name and gender identity as requested.	15
4	Review CNAS Resolution 109/2009, which approves the National Typification of Social Assistance Services, including the creation of specific services aimed at migrants, refugees and stateless persons, such as: Migrant Reference Center and Institutional Reception Units, with the hiring of migrant professionals.	13
5	Create a national fund to support the development, implementation and execution of specific public policies for migrants, refugees, stateless persons and returnees.	14
6	Create and institute a special secretariat, subordinate to the Presidency of the Republic, responsible for policies directed to the migrant population and, associated with it, committees, in the ministries of the Executive, for the elaboration, implementation and monitoring of actions of the respective bodies, for the migrant populations, guaranteeing the participation, with the right to voice and vote, of migrant, refugee, stateless and returned people	17

2	Request the amendment of article 153 of Decree 9.199/2017 to the Federal Executive, to ensure the broad exercise of the right to family reunification of migrants, refugees, stateless persons, as recognized in article 37 of the Migration Law, determining that the residence permit and the visa for family reunion may be granted to ascendants and descendants of first and second degree of consanguineous kinship and by affinity, in the event that the "caller" has been the beneficiary of a residence permit for family reunion or provisional residence permit, in order to enable the caller to become a "caller".	20
3	Flexibilize the requirement of documentation of the country of origin for the purposes of migratory regularization and naturalization for: 1) Migrants, refugees and stateless persons from countries without official representation in Brazil, as well as those classified as serious and widespread violations of human rights and/or affected by armed conflicts, humanitarian, political and economic crises; 2) Hyposufficient migrants with exemption from fees and emoluments of consular fees; 3) Exemption from translation of criminal records certificate issued in Spanish-speaking countries.	13
4	Request the MJSP to issue a standard that establishes: 1) The validity period of documents issued abroad related to the marital status of migrants, refugees, stateless persons and returnees, whether declared in the document itself established by the competent body of the country of origin or when it is not possible to identify it in the document, the one that determines the Brazilian legislation for equivalent documents prevails; 2) Exemption from fees and emoluments charged in Brazil (civil registry offices) and consular fees for migrants, refugees, stateless persons and hyposufficient returnees.	15
7	Flexify the rules that provide for the revalidation of higher education diplomas issued by foreign HEIs, changing the wording of MEC Ordinance No. 1.051/2023, to eliminate the "nomination and titling of the teaching staff" from the list of documents that must be presented by the applicant; and remove the requirement for apostille/legalization of school documents of migrants, refugees, stateless persons and returnees issued by countries that are affected by armed conflicts, humanitarian, political and economic crises.	17
10	Grant the residence permit for an indefinite period for migrants who prove continued residence in Brazil for a minimum period of three years, with family ties, demonstration of social and economic integration in Brazil (such as microentrepreneurs), absence of criminal records in Brazil and in the country where they lived in the last five years, as well as guaranteeing them entry into Mercosur countries (regardless of their nationality).	13

Order	NATIONAL PROPOSALS DISCUSSED Axis VI – Coping with Violation of Rights	Votes (%)
1	Promote a permanent institutional policy for the training and awareness of public servants and agents of the Unified Public Security System (SUSP), aiming at better treatment in the provision of services and care aimed at migrants, including, in an intersectional way, the cuts of gender and sexuality diversity, seeking to prevent and face the violation of rights and paying attention to the language barrier. This should include the expansion of language course options offered to these agents and actions should be contemplated to promote humanized care for migrant women (cis and trans) in situations of domestic and family violence against women, sensitizing and training susp professionals who work in the implementation of the Maria da Penha Law.	17
2	Map, monitor and monitor the situation and conditions of migrants, refugees, stateless and returned people, in deprivation of liberty in the Prison System and in the Socio-Educational System, in order to guarantee their rights, their dignity and the implementation of actions to prevent and confront institutional violence, considering the specificities of language, gender, origin, ethnicity, race, religion, sexual orientation, among others.	11
3	Ensure access to SUS for undocumented migrants, refugees and stateless persons/ with expired documentation, paying attention to those with difficulties in accessing the diplomatic representations of their countries, such as migrants from African, Latin American, indigenous countries, from countries without diplomatic representation in Brazil and/or those persecuted by their national states of origin, whether they have been granted refugee status or not, and considering the specificities of language, gender, origin, ethnicity, race, religion, sexual orientation, among others.	20
6	Create protocols to combat racism and xenophobia that facilitate and guide qualified care for possible migrant, refugee, stateless and returned victims, as well as adopt measures to preserve evidence and immediately activate the Police Station Specialized in xenophobia crimes, so that it has access to the necessary information for the proper referral of the complaint, and considering the specificities of gender, race, ethnicity, religion, nationality, sexuality, among others.	20
7	Create specialized integrated and intersectoral care centers for migrants, refugees and stateless persons, with safe spaces and channels for reporting rights violations.	14
